## **Stonegate Supports Regional Water Sustainability Efforts**

Exciting news for the Stonegate Village Metropolitan District, as a number of districts and organizations throughout the Denver south metro area formalize a partnership to with WISE (Water Infrastructure and Supply Efficiency) for creating and improving sustainable new water supply as well as address future drought condition supply.

Throughout the region there are a number of independent community water resources and infrastructures, and although each community's facilities provide great benefit and features for their customers...it is recognized that by pooling the collective efforts and resources of the entire region...all districts will dramatically benefit by improved operational efficiencies and sustainable water supplies.

As a member of the South Metro Water Supply Authority, the Stonegate Village Metropolitan District the Board of Directors has been actively involved in the planning and evaluating sustainable water options, and will proactively work with Denver Water, Aurora Water and the 14 district members to focus improvements on water management, sustainable and conservation efforts for the south metro region. Recently, many of the South Metro Districts including SVMD, joined Aurora Water on an all-day tour of the Prairie Waters Project. Attendees visited new resources and facilities, as well as met with Aurora Water Staff and reviewed valuable project information of the extensive \$600 million water and wastewater project. Prairie Waters Project uses both natural cleansing processes and state-of-the-art purification technology to deliver an additional 3.3 billion gallons of water per year, and the Prairie Waters Project facilities also have treatment capacity of 50 million gallons per day. Most notably, the project was delivered ahead of schedule and \$100 million under budget. Many of these milestones and lessons learned will help attendees evaluate and plan for future projects throughout the south metro region.

In other related news, the South Metro WISE Authority a separate organization that supports the implementation and participation of WISE, recently announced the election of SVMD District Manager, Mitch Chambers of Mulhern, MRE, to the Executive Board of the South Metro WISE Authority (SMWA). With the election of our District Manager on the Executive Board, gives SVMD a strong voice and position in this 10 member organization which includes the Metropolitan and Sanitation Districts of Castle Rock, Centennial, Cottonwood, Dominion, Inverness, Meridian, Parker, Pinery, Rangeview and Stonegate Village.
